### **WORKFORCE SOLUTIONS**

### AREA PROFESSIONALS EXPLORE SECOND CHANCE HIRING

On February 9th, over 100 local CEOs, business leaders, and HR professionals attended a morning workshop on recruiting, hiring, and retaining individuals with criminal backgrounds. Greater Dubuque Development, in partnership with the Tri-State Human Resource Association (TRIHRA), Iowa Works, Express Employment, Northeast Iowa Community College, Dubuque Works partners, and Fountain of Youth program sponsored the workshop, held at the NICC Town Clock Business Center.

Keynote speaker Kyle Horn, founder of America's Job Honor Awards, provided insight into this unique segment of the workforce. While some individuals with a criminal background are not ready to rejoin the workforce, he offered advice and criteria for assessing those who are. A candidate who has made steps to change his or her life and move past their mistakes has potential to be a highly valued employee. By equipping those individuals with training and guidance, they are better prepared to succeed. Training programs, like those offered through Opportunity Dubuque, are an excellent way to move candidates into high-paying careers and achieve long-term success.

The event also featured a simulation hosted by U.S. Attorney, Justin Lightfoot, from the U.S. District Attorney's Office - Northern District of Iowa. Participants were given a created identity of an ex-offender and visited various stations to simulate the day to day challenges faced by those with a criminal background. Over fifteen stations included employers, identification stations, urinalysis, transportation, daily errands, and medical care. Participants had to navigate the stations and face surprise challenges like contracting the flu or being evicted when rent isn't paid. While a simple illustration, participants were amazed at the various challenges facing those trying to rejoin the workforce.

Other presentations included EEOC Guidance and Best Practices from local workforce attorney Davin Curtiss, an employer panel on best practices, and the presentation of Dubuque's Second Chance Hiring program to train and vet potential candidates.

### **GREATER DUBUQUE DEVELOPMENT HOSTS EXPERTS IN ASIA TRADE**



The panel answered questions from area business and community leaders.

On February 7th and 8th, trade experts from the Iowa Economic Development Authority were in the Greater Dubuque area to visit businesses and share information on expanding trade to Southeast Asia and China. Over 30 area business leaders were on hand for a presentation held at the Diamond Jo Casino. "Rethink Your Asia Strategy" presented the opportunities and challenges of doing business in these countries.

Joseph Rude, IEDA's marketing manager for Asia/Pacific trade, indicated that tough talk on industrial trade and free trade agreements could affect policy but that shouldn't hinder taking advantage of opportunities. The region currently holds 60% of the world population and 27% of the world's consumption and both are increasing. Certain sectors would have greater

potential in the region - agricultural, food processing and safety, medical and elder care, educational, and environmental safety products are currently seeing successful growth.

Sarath Menon, IEDA's Southeast Asia representative, and John Clarke, IEDA's China representative, also encouraged area businesses to consider expanding to those regions. ### **DUBUQUE TAKES NEXT STEP ON LOCALLY PRODUCED, RENEWABLE ENERGY**

The Dubuque City Council recently approved agreements with Eagle Point Solar of Dubuque for the installation of rooftop solar on the City's Fire Stations. In addition to reducing electricity costs by an estimated 30% for the Fire Department, over the lifetime of the installations they will off-set the greenhouse gas equivalent of 425 Dubuque homes. The City also avoided any up-front costs for the installation by entering into a Power Purchase Agreement with Eagle Point Solar, whereby Eagle Point finances the system in return for the City providing the rooftop space and agreeing to purchase the power.

"This is another win/win/win on renewable energy" said David Lyons. Sustainable Innovations Consultant with Greater Dubuque Development. "Taxpayers save money, environmental impact is reduced, and a local company grows."

MAP OF RELOCATION GUIDES DISTRIBUTED TO INDIVIDUALS IN JANUARY 2017





#### JOB CREATION UPDATE


The resident unemployment rate for December 2016 was reported as 3.4% and non-farm employment was 62,000.


