# ***Rockfarm Holdings Chooses Dubuque Technology Park for New Corporate Headquarters***

**Dubuque, IA** – Rockfarm Holdings, Inc. announced plans to relocate their corporate operations to Dubuque, Iowa, bringing 48 new positions into the Dubuque job market. The company will invest over \$2.5 Million as they construct their new headquarter facility in the Dubuque Technology Park.

Once Rockfarm Holdings finalizes the purchase of the property and a TIF agreement with the City of Dubuque, they plan to break ground in the fall of 2014.

“After the evaluation and strong efforts by both the states of Iowa and Illinois and the cities of Dubuque and East Dubuque, we chose Dubuque as the new location for our corporate functions,” said Todd Colin, Chief Executive Officer of Rockfarm Holdings. “The environment in the Dubuque Technology Park is conducive to a corporate office and will help us grow our business,” noted Colin.
